## Preface

Not suitable for children under 3 years.



Do not insert pins.



Do not use folded or rucked.



Do not tumble dry.

## Safety Instructions

1. The appliance is an over blanket.
2. The product is only to be used with the control unit SS09, which is marked on the product.
3. When the appliance is likely to be used for an extended period, such as when the user is falling asleep, the controls should be adjusted to position
4. If the appliance is slept on with the controls set to a higher temperature, the user may suffer skin burns or heat stroke.
5. Children shall not play with the product.
6. Do not use the product when wet.
7. This appliance is not intended for medical use in hospitals.
8. Children under the age of three are not to use this appliance due to their inability to react to overheating.
9. The product is not to be used by young children over the age of three

unless the controls have been pre-set by a parent or guardian, and unless the child has been adequately instructed on how to operate the controls safely.

**10.** This appliance can be used by children aged 8 years and above, and persons with reduced physical, sensory, or mental capabilities or lack of experience and knowledge, provided they have been given supervision or instruction concerning the safe use of the appliance and understand the hazards involved.

**11.** The appliance can be used by children older than 3 years and younger than 8 years under supervision and with the control always set to the minimum temperature value.

**12.** The product must not be used by persons insensitive to heat or other very vulnerable persons who are unable to react to overheating.

**13.** This appliance is not intended for use by persons (including children) with reduced physical, sensory, or mental capabilities, or lack of experience and knowledge, unless they have been given supervision or instruction concerning the use of the appliance by a person responsible for their safety.

**14.** If the supply cord is damaged, it must be replaced by the manufacturer, its service agent, or similarly qualified persons in order to avoid a hazard.

**15.** The cable and control unit of the appliance can give rise to risks of entanglement, strangulation, tripping, or treading if not correctly arranged. The user shall make sure that excess ties and electric cords are arranged in a safe way.

**16.** Examine the product frequently for signs of wear or damage. If there are such signs, or if the product has been misused, return it to the supplier prior to any further use.

**17.** Cleaning and user maintenance shall not be made by children without supervision.

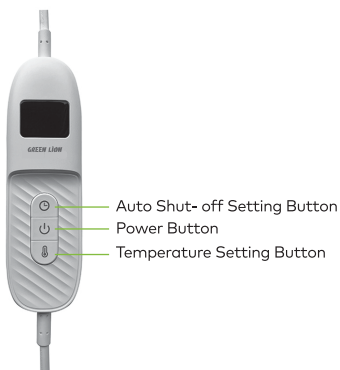
**18.** When storing the appliance, please make sure it's dry before folding.

**19.** Store the product in a clean and dry place.

**20.** Never place any object on the product.

## Device Operation

1. Plug in the power cord, the device will self-check, all displays will light up for 1 second, then the heating element will not heat up, entering standby mode.
2. Press the power button briefly to turn on the device, entering the default mode. The default mode is level 1, 5 hour.
3. There is only one digital tube, which cannot display the level and timing at the same time. So, the digital tube's small round dot lights up and goes out to distinguish between heating level and timing level. The small round dot lights up to represent the current remaining timing, and the small round dot goes out to represent the current digital tube displaying the heating level. Each short press of the level button increases the level by one, in the order of 5→4→3→2→1→9→8→7→6→5, and cycles.
4. Pressing the "Timer" button allows for a cycle selection of "9-1 hours."
5. Each time you press the "Timer" button, the digital tube will flash 2 times (approximately 3-2 seconds). After the controller enters the time setting and timing status, the small round dot at the bottom right corner will light up to distinguish between temperature adjustment and timing adjustment status; when the controller is working normally, pressing the timer button will display the current remaining time.
6. The level and timer buttons have a long press quick adjustment function.

## Maintenance & Cleaning

1. Before cleaning, always let the product cool down and disconnect it from the mains.
2. Unplug the control unit from the heated blanket by pulling out the connection cable from the plug on the heated blanket.
3. Clean the heating blanket (without control unit) according to the laundry care symbols on the label.
4. Do not machine dry, chemically clean, wring out, press, or iron the heating blanket.
5. Only use the heating blanket again when it is completely dry.



## Disposal

This product must not be disposed of as unsorted household waste. It is important to separate such waste for proper treatment and recycling, in compliance with local waste management regulations.

## Warranty
