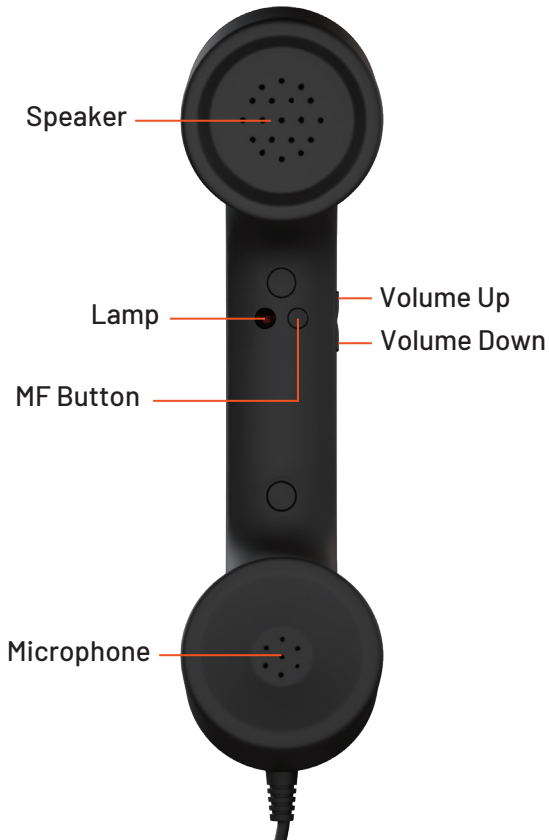
Product Overview

Operation Guide

1. Connect the Type-C connector to a compatible audio device to start using the headphones.
2. Hold the receiver close to your ear for optimal sound.
3. These headphones are compatible with most smartphones and devices that support a Type-C auxiliary connection.
4. Button Functions

a. Volume Up: Press the + button.

b. Volume Down: Press the - button.

Play/Pause Music & Answer Calls: Press the MF button once.

Next Track: Press the MF button twice.

Previous Track: Press the MF button three times.

Reject Call: Press and hold the MF button.

Safety Precautions

- 1.** Use the device only for its intended purpose.
- 2.** Keep away from hot surfaces and open flames.
- 3.** Place the device on a level, stable, clean, and dry surface.
- 4.** Protect the device from extreme temperatures, dust, direct sunlight, humidity, and water exposure.
