Safety Precautions

1. Do not disassemble this device without authorization. This product does not contain any parts that can be disassembled or maintained independently.

5. For safety, remove the power input cable when the product is not in use.

8. If the product behaves abnormally, such as leakage or expansion, stop using it immediately and contact customer service.
9. If liquid from the product comes into contact with your eyes, do not rub them. Rinse your eyes immediately with clean water. In serious cases, seek medical attention.
