## **Button Functions**

1. Click to start the white light.
2. Click to turn on the warm light.
3. Click to turn on the colorful breathing light.
4. Click to fix the light color.
5. Click to power off.
6. Double-click the button to activate the independent switch spray function.
7. Press and hold the button to adjust the brightness of the light.

## **Precautions**

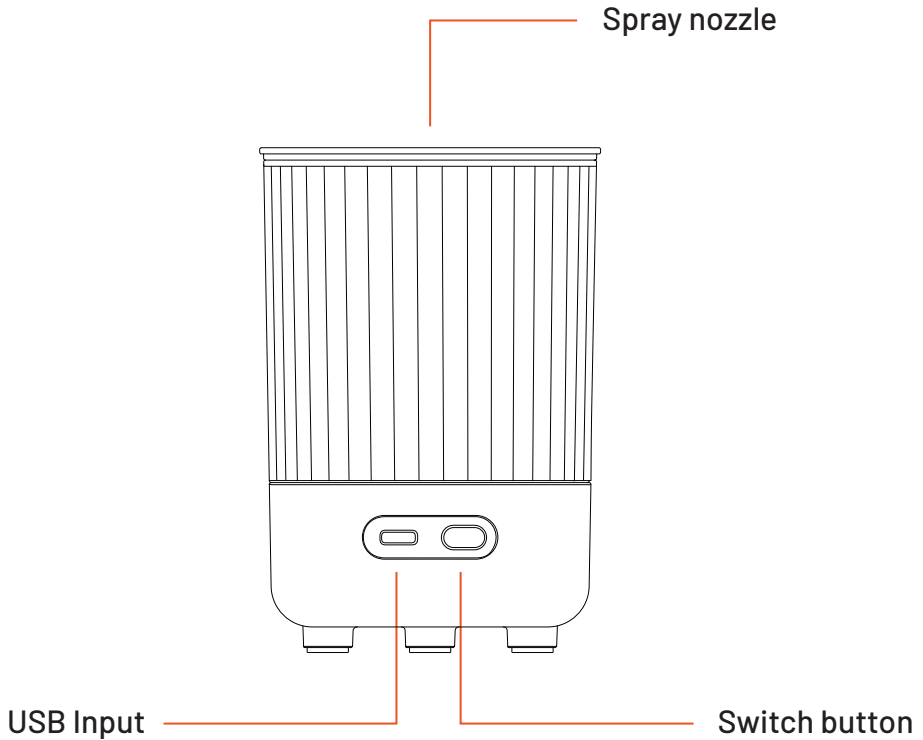
1. The maximum water volume of the tank is 150 ml. Do not exceed the maximum water level indicator line, as it may affect the atomization effect.
2. Use a DC 5V–2A input power supply to ensure proper atomization; using the wrong power supply may damage the device or reduce its effectiveness.
3. Only use pure water in the atomizer to prevent damage caused by impurities. This ensures the best performance and maintenance.
4. The sound emitted from inside the water tank during operation is the normal noise of the atomizer working and is not a cause for concern.
