

## Product Overview



# Schematic View




Type-C Charging Cable



## Charging Guide

To charge the pen, connect the Micro-USB cable to the charging port on the pen and plug the other end into your charging device. The indicator light will turn red while charging and will change to green when fully charged.



## Usage Guide

1. To activate the pencil, press the power button.
2. A blue indicator light will confirm that the pencil is on.
3. Press the power button again to turn it off.

**NOTE:** If no action is taken within 5 minutes, the pencil will automatically power down to conserve energy.

## Troubleshooting

1. This pencil does not have Bluetooth functionality and does not require any app or Bluetooth pairing.
2. If the pen does not recognize touch input, check device compatibility or restart the device.

3. Disabling Bluetooth on your device may help resolve any conflicts with the pencil.

## Safety Precautions

1. Disassembling, repairing, or modifying the pencil voids the warranty and may pose a risk to both the user and the device.
2. Avoid exposing the pencil to extreme temperatures or moisture during operation or charging.
3. Do not leave the pencil connected to power after charging is complete, as this may impair battery lifespan.
4. Keep the pencil and its components out of the reach of children to prevent choking hazards.

## FCC Statement

1. This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions:
