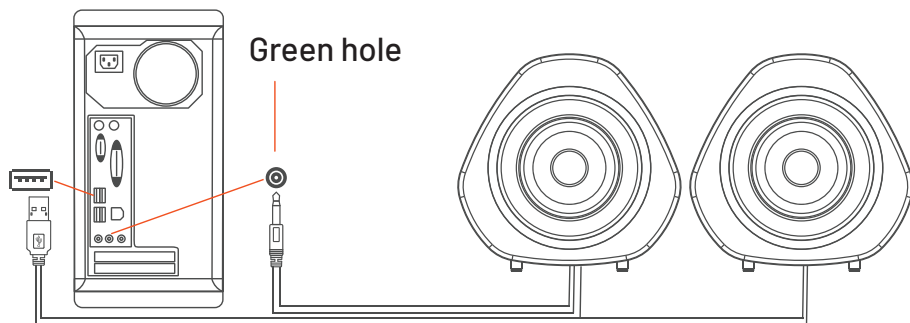

Connection Guide

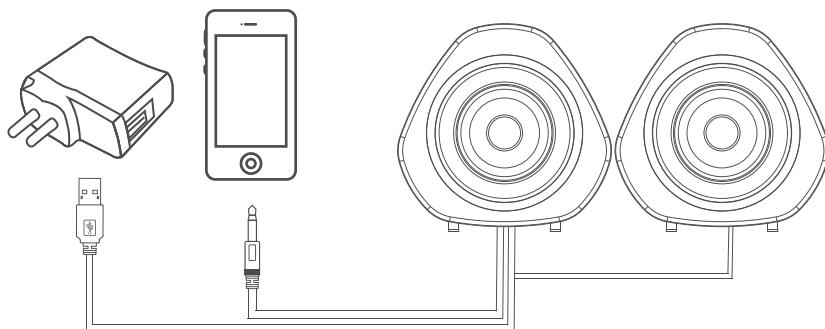
1. Connecting to PC

Connect both USB cable and the 3.5mm jack to your PC for better sound quality.



2. Connecting to Phone and Tablet

Connect the 3.5mm jack to your phone and the USB cable to an adapter for power.



Safety Precautions

1. The speaker requires a 5V DC power supply, and the audio input is a 3.5mm universal audio interface.
2. Place the speakers in a cool, dry environment. Avoid exposure to direct sunlight or humid areas. Ensure they are placed on a stable surface.
3. These speakers use a DC 5V power supply, connected via a USB cable. The voltage must match the power supply exactly, and it should not exceed or fall short of the required value. These speakers only support a 3.5mm universal audio input—other inputs are not compatible.
4. Do not attempt to open the rear shell. If the product needs repair, please send the unit to our company or a professional maintenance service.
5. Ensure that the speakers are not subjected to heavy vibrations or shocks, as these can affect performance and cause internal damage.

FCC Statement

1. This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions:

- (1) This device may not cause harmful interference; and
- (2) This device must accept any interference received, including interference that may cause undesired operation.
